## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport to hospital or medical centre.

## 10. STABILITY AND REACTIVITY

**Chemical stability:** Product is stable under normal conditions of use, storage and temperature.

**Conditions to avoid:** Heat, sparks and flame.

**Incompatible materials:** Reactive metals (e.g. sodium, calcium, zinc, etc.) Materials reactive with hydroxyl compounds. Organic acids. Mineral acids. Sodium hypochlorite. Oxidising agents.

**Hazardous decomposition products:** Nitric acid. Ammonia. Oxides of nitrogen. Nitrogen oxides can react with water vapours to form corrosive nitric acid. Carbon monoxide. Carbon dioxide (CO<sub>2</sub>). Aldehydes. Flammable hydrocarbon fragments.
