4. FIRST AID MEASURES

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. For gross contamination, immediately drench with water and remove clothing. Continue to flush skin and hair with plenty of water (and soap if material is insoluble). 10. STABILITY AND REACTIVITY

Chemical stability: Stable under normal ambient and anticipated storage and handling conditions of temperature and pressure. The amount of available chlorine diminishes over time.

Conditions to avoid: Avoid contact with foodstuffs. Avoid exposure to heat, sources of ignition, and open flame. Avoid exposure to light. Avoid contact with other chemicals. Avoid contact with acids .
