4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: Effects may be delayed. If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. For gross contamination, immediately drench with water and remove clothing. 10. STABILITY AND REACTIVITY

Chemical stability: Product is stable under normal conditions of use, storage and temperature.

Conditions to avoid: Heat, sparks and flame.

Incompatible materials: Reactive metals (e.g. sodium, calcium, zinc, etc.) Materials reactive with hydroxyl compounds. Organic acids. Mineral acids. Sodium hypochlorite. Oxidising agents.

Hazardous decomposition products: Nitric acid. Ammonia. Oxides of nitrogen. Nitrogen oxides can react with water vapours to form corrosive nitric acid. Carbon monoxide. Carbon dioxide (CO2). Aldehydes. Flammable hydrocarbon fragments.

Hazardous reactions: Product slowly corrodes copper, aluminium, zinc and galvanised surfaces. Reaction with peroxides may result in violent decomposition of peroxide possibly creating an explosion.
