4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Effects may be delayed. Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If breathing laboured and patient cyanotic (blue), ensure airways are clear and have a qualified person give oxygen through a facemask. If breathing has stopped apply artificial respiration at once. In the event of cardiac arrest, apply external cardiac massage. Seek immediate medical advice.

Skin Contact: Effects may be delayed. If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre or a Doctor; or for 15 minutes and transport to Doctor or Hospital. For gross contamination, immediately drench with water and remove clothing. Continue to flush skin and hair with plenty of water (and soap if material is insoluble). 10. STABILITY AND REACTIVITY

Chemical stability: Stable at normal room temperature and pressure.

Conditions to avoid: Heat, sparks, flame and build up of static electricity.

Incompatible materials: Avoid contact with water, strong alkalis, mineral acids, halogens, strong oxidizers (liquid chlorine, concentrated oxygen, sodium hypochlorite), alcohols, amines, metal compounds, detergent solutions, rubber, polyethylene and PVC, and most tank linings.Alkali metal hydroxides -hydrolysis can occur), potassium tert-butylate(ignition can occur).

Hazardous reactions: Exothermic reaction with amines and alcohols; reacts slowly with water forming carbon dioxide; foaming in confined spaces / closed containers - risk of bursting owing to increase of pressure. Reacts with water, may generate a large volume of foam, carbon dioxide gas and heat. Iso-cyanates will attack and embrittle some plastics and rubbers. Forms toxic fumes when thermally decomposed.
