4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Notes to physician: Treat symptomatically. Brodifacoum is an indirect anti-coagulant. Phytomenadione, Vitamin K, is antidotal. Determine prothrombin time not less than 18 hours after consumption. If elevated, administer Vitamin K1 until prothrombin time normalises. Continues determination of prothrombin time for two weeks after withdrawal of antidote and resume treatment if elevation occurs in that time.
