2. HAZARDS IDENTIFICATION

Based on available information, this material is not classified as hazardous according to criteria of Safe Work Australia.

This product is made from organic materials, including composted pinebark, and contains living microorganisms, including bacteria, fungi and protozoa. May also contain mineral and fertiliser additives.

Inhalation of dust and/or liquid mists may irritate, inflame or sensitise the nose, throat and lungs resulting in illnesses ranging from hayfever or asthma, to pneumonia (eg Legionnaire's disease) or pneumonia-like illnesses. Direct contact with this material or its dust and/or liquid mists {bioaerosols} may cause skin irritation {dermatitis}, and skin or eye infection or irritation. SMALL SPILLS
