4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

In case of accident or if you feel unwell, seek medical advice immediately (show product label where possible). **ADVICE FOR DOCTORS:** Difenacoum is an anticoagulant which may produce bleeding; this may be delayed for several days after exposure. If there is no active bleeding the INR (prothrombin time) should be measured on presentation and 48-72 hours after exposure. If the INR is greater than 4, administer Vitamin K1 (phytomenadione) 5-10mg by slow intravenous injection (100g/kg body weight for a child). Treatment with phytomenadione (orally or intravenously) may be required for several weeks.
