# 4. FIRST AID MEASURES

If there is no active bleeding the INR (prothrombin time) should be measured on presentation and 48-72 hours after exposure. If the INR is greater than 4, administer Vitamin K1 (phytomenadione) 5-10mg by slow intravenous injection (100g/kg body weight for a child). Treatment with phytomenadione (orally or intravenously) may be required for several weeks.
