2. HAZARDS IDENTIFICATION

This product is made from organic materials, including composted pinebark, and contains living microorganisms, including bacteria, fungi and protozoa. May also contain mineral and fertiliser additives.

Inhalation of dust and/or liquid mists may irritate, inflame or sensitise the nose, throat and lungs resulting in illnesses ranging from hayfever or asthma, to pneumonia (eg Legionnaire's disease) or pneumonia-like illnesses.
