Skin Contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. 7. HANDLING AND STORAGE

Keep containers closed when not in use - check regularly for leaks.
