Inhalation: Irritating to upper respiratory tract if sprayed, especially in strong solutions.

Skin Contact: Corrosive to skin – may cause skin burns. Contact with skin will result in severe irritation.

Eye contact: Corrosive to eyes. Will cause severe irritation and chemical burns. Contamination of eyes can result in permanent injury or blindness.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.
