### 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

If blistering occurs, do NOT break blisters. If swelling, redness, blistering, or irritation occurs seek medical assistance.
