4. First aid measures

General : In all cases of doubt, or when symptoms persist, seek medical attention. If

unconscious, place in recovery position and seek medical advice. Never give

anything by mouth to an unconscious person.

Inhalation : Remove to fresh air. Keep person warm and at rest. If breathing is irregular or

stopped, administer artificial respiration. If breathing is difficult, give oxygen.

Get medical attention.

Eye Contact : Immediately irrigate copiously with clean water for 5-10 minutes, keeping

eyelids open. Get medical attention.

Skin Contact : Remove contaminated clothing and shoes. Wash skin thoroughly with soap and

water or use a suitable skin cleaner. Do NOT use solvents or thinners.

Ingestion : Seek immediate medical attention. Keep person warm and at rest. DO NOT

induce vomiting. If vomiting, hold down the head to reduce the risk of getting

stomach content into the lungs.

Burns : Rinse with water until the pain ceases. During rinsing, remove clothes, which

are not burnt on, from the damaged area. In severe cases, rinse with tepid water for 30-40 minutes or until medical staff arrive. If possible, protect the burnt area

with a bandage, clean towel or similar. Prevent shock.

5. Fire-fighting measures

Extinguishing media

Suitable : Use dry chemical, CO₂, water spray (fog) or foam.

Not suitable : Do not use water jet.

Special exposure hazards: Promptly isolate the scene by removing all persons from the vicinity of the incident

if there is a fire. No action shall be taken involving any personal risk or without suitable training. Move containers from fire area if this can be done without risk.

Use water spray to keep fire-exposed containers cool.

Highly flammable liquid. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. The vapour/gas is heavier than air and will spread along the ground. Vapours may acculate in low or confined areas or travel a considerable distance to a source of ignition and flash

back. Runoff to sewer may create fire or explosion hazard.

6. Accidental release measures

Personal precautions : Avoid contact with spilled or released material. Shut off leaks, if possible without

personal risks. Isolate hazard area and deny entry to unnecessary or unprotected personnel. Remove all sources of ignition in the surrounding area. Take precautionary measure against static discharge. Ensure electrical continuity by

bonding and earthing all equipment.

Environmental precautions: Use appropriate containment to avoid environmental contamination. Prevent from

spreading and entering waterway using sand, earth or other appropriate barriers. Attempt to disperse the vapour or to direct its flow to a safe location for example by

using fog sprays. Ventilate contaminated area thoroughly.

Methods of cleaning up : For small spills (< 1 drum), transfer by mechanical means to a labelled, sealable

container for product recovery or safe disposal. Allow any residues to evaporate or

use an appropriate absorbent material and dispose of safely.

For larger spills (> 1 drum), transfer by means such as a vacuum truck to a salvage

tank for recovery or disposal. Do not flush residues with water. Retain as contaminated waste. Allow any residues to evaporate or use an appropriate

absorbent material and dispose of safely.

7. Handling and storage

Handling : Highly flammable product. Avoid breathing vapours. Handle and open containers

with care in a well- ventilated area. Ensure that the workplace is ventilated such that the Occupational Exposure limit is not exceeded. Avoid contact with skin, eyes and clothing. Wash thoroughly after handling. Do not eat, drink or smoke in contaminated areas. Electrostatic charges may be generated during transfer. Electrostatic discharge may cause fire. Ensure electrical continuity by earthing all equipment.

Flameproof equipment necessary in area where chemical is being used. Vapours may accumulate in low or confined areas.

Storage : Bulk storage tanks should be bunded. Store in a well-ventilated area, away from

sunlight, ignition sources and other sources of heat. Do not store near strong

oxidants.

8. Exposure controls/personal protection

Engineering measures : Provide exhaust ventilation or other engineering controls to keep the airborne

concentrations of vapours below their respective Occupational Exposure Limits. Ensure that eyewash stations and safety showers are close to the

workstation location.
