### 4. FIRST AID MEASURES

away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Store locked up. Store in corrosive resistant container with a resistant inner liner. Keep container standing upright. Keep containers closed when not in use - check regularly for leaks.
