4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Eye contact: If in eyes wash out immediately with water. In all cases of eye contamination it is a sensible precaution to seek medical advice.

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious patient. If vomiting occurs give further water. Seek medical advice.

PPE for First Aiders: Wear safety shoes, overalls, gloves, safety glasses. Available information suggests that gloves made from nitrile rubber should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Notes to physician: Treat symptomatically. Brodifacoum is a coumarin anticoagulant. It interferes with the synthesis of prothrombin, disrupting the normal clotting mechanism of the blood and leading to an increased tendency to bleed. As a result effects may be delayed. HUMAN – Treatment for brodifacoum poisoning is the administration of Vitamin K1 for as much time as it takes (sometimes weeks) for blood parameters to return to normal. In the early phase of poisoning, the infusion of fresh-frozen plasma containing clotting agents is advisable.DOMESTIC ANIMALS EXHIBITING SIGNS OF POISONING – Treatment involves the administration of Vitamin K1. 1. Carry out a prothrombin test. Administer parentally 2 – 5 mg/kg of Vitamin K1. Use the smallest diameter needle feasible and avoid the intravenous route if possible in severely haemorrhagic animals.2. Repeat

prothrombin test 4 hours following the first treatment of Vitamin K1. Provided that the prothrombin test has normalised, start daily oral Vitamin K1 treatment for 3 to 4 weeks.3. After 1 to 2 days, following cessation of Vitamin K1 treatment repeat the prothrombin test. Continue Vitamin K1 treatment if prothrombin time is still abnormal or if signs of poisoning reappear.
