## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

## 5. FIRE-FIGHTING MEASURES

**Hazchem Code:** Not applicable.

**Suitable extinguishing media:** Not combustible, however, if material is involved in a fire use water fog (or if unavailable fine water spray), foam, dry agent (carbon dioxide, dry chemical powder).

**Specific hazards:** Non-combustible material.

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal.
