# 4. FIRST AID MEASURES

**Description of first aid measures:** If poisoning occurs, contact a doctor or the National Poisons Information Service (Phone 111) or Ambulance (Phone 999).

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.
