## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Effects may be delayed. Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. If breathing laboured and patient cyanotic (blue), ensure airways are clear and have a qualified person give oxygen through a facemask. If breathing has stopped apply artificial respiration at once. In the event of cardiac arrest, apply external cardiac massage. Seek immediate medical

**Skin Contact:** Effects may be delayed. If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

WES-TWA (Workplace Exposure Standard - Time-weighted average). The average airborne concentration of a substance calculated over an eight-hour working day.

WES-Ceiling (Workplace Exposure Standard - Ceiling). A concentration that should not be exceeded at any time during any part of the working day.

WES-STEL (Workplace Exposure Standard - Short-term exposure limit). The 15-minute time weighted average exposure standard.
