4. FIRST AID MEASURES

LARGE SPILLS

Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. WES-TWA (Workplace Exposure Standard - Time-weighted average). The average airborne concentration of a substance calculated over an eight-hour working day.

WES-Ceiling (Workplace Exposure Standard - Ceiling). A concentration that should not be exceeded at any time during any part of the working day.
