Suitable Extinguishing Media:

Not combustible, however, if material is involved in a fire use: Fine water spray, normal foam, dry agent (carbon dioxide, dry chemical powder).

Not combustible, however following evaporation of the water component of the material, the residual material can burn if ignited. On burning will emit toxic fumes, including those of oxides of carbon and oxides of sulfur .

Fire fighters to wear self-contained breathing apparatus and suitable protective clothing if risk of exposure to vapour or products of combustion.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS: Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.

TWA - The time-weighted average airborne concentration of a particular substance when calculated over an eight-hour working day, for a five-day working week.
