Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. 5. FIRE-FIGHTING MEASURES

7. HANDLING AND STORAGE
