4. FIRST AID MEASURES

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Shut off all possible sources of ignition. Clear area of all unprotected personnel. Prevent further leakage or spillage if safe to do so. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. WES-TWA (Workplace Exposure Standard – Time-weighted Average). The time-weighted average exposure standard designed to protect the worker for the effects of long-term exposure.

WES-STEL (Workplace Exposure Standard - Short-Term Exposure Limit). The 15-minute average exposure standard. Applies to any 15-minute period in the working day and is designed to protect the worker against adverse effects of irritation, chronic or irreversible tissue changes, or narcosis that may increase the likelihood of accidents. The WES-STEL is not an alternative to the WES-TWA; both the short-term and time-weighted average exposures apply.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept too as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.
