**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Skin Contact:** Effects may be delayed. If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water.
