## 4. FIRST AID MEASURES

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Skin Contact:** If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

### SMALL SPILLS

**Hazardous reactions:** Under wet conditions, sodium chloride will corrode many common metals, particularly iron, aluminium and zinc. Reacts with strong sulphuric acid or nitric acid liberating hydrogen chloride gas.
