4. FIRST AID MEASURES

Skin Contact: Effects may be delayed. If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. For gross contamination, immediately drench with water and remove clothing. Continue to flush skin and hair with plenty of water (and soap if material is insoluble). For skin burns, cover with a clean, dry dressing until medical help is available. 6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

7. HANDLING AND STORAGE

Handling: Avoid eye contact and skin contact. Avoid inhalation of dust.
