## 4. FIRST AID MEASURES

**Inhalation:** Effects may be delayed. Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.
