## 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**WES-TWA (Workplace Exposure Standard - Time-weighted average).** The average airborne concentration of a substance calculated over an eight-hour working day.

**WES-Ceiling (Workplace Exposure Standard - Ceiling).** A concentration that should not be exceeded at any time during any part of the working day.

**WES-STEL (Workplace Exposure Standard - Short-term exposure limit).** The 15-minute time weighted average exposure standard. Applies to any 15-minute period in the working day and is designed to protect the worker against adverse effects of irritation, chronic or irreversible tissue change, or narcosis that may increase the likelihood of accidents.
