4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: This material, or a component of the material, can be absorbed through the skin with resultant toxic effects. If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. 7. HANDLING AND STORAGE

10. STABILITY AND REACTIVITY

Chemical stability: Exposure to heat and sunlight may decompose sodium chlorite into chlorine dioxide with the



risk of over pressuring sealed containers.

Conditions to avoid: Elevated temperatures and sources of ignition.

Incompatible materials: Acids and reducing agents. Do NOT use steel, aluminium, copper and copper alloys, rubber for storage or transfer of this product.

Hazardous decomposition products: Sodium chlorate and oxygen.

Hazardous reactions: Contact with acids liberates toxic gas. Formation of explosive mixtures upon exposure to acids. Contact with reducing agents may cause a violent reaction with evolution of heat. Contact with acidic materials, aluminium polychloride, ferric chloride and magnesium sulphate promotes release of chlorine dioxide.

11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Acute Effects

Inhalation: Material may be an irritant to mucous membranes and respiratory tract.

Skin contact: Harmful in contact with skin. Can be absorbed through the skin with resultant toxic effects. Contact with skin will result in severe irritation. Corrosive to skin - may cause skin burns.
