This product is classified as: Xi, Irritating. Hazardous according to the criteria of SWA.

This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The SWA TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that may be equalled (but should not be exceeded) for no longer than 15 minutes and should not be repeated more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

### Section 4 - First Aid Measures

#### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 1126 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Inhalation:** If irritation is experienced, remove victim from area and allow to breath fresh air. If irritation persists, call a doctor or poisons information centre.

**Skin Contact:** Quickly and gently brush away excess solids. Wash gently and thoroughly with water (use non-abrasive soap if necessary) for 10 minutes or until chemical is removed. If irritation persists, repeat flushing and obtain medical advice.

**Eye Contact:** Quickly and gently brush particles from eyes. Immediately flush the contaminated eye(s) with lukewarm, gently flowing water for 20 minutes or until the product is removed, while holding the eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Obtain medical attention immediately. Take special care if exposed person is wearing contact lenses.

**Ingestion:** If swallowed, do NOT induce vomiting. Wash mouth with water and contact a Poisons Information Centre, or call a doctor.

### Section 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** There is no risk of an explosion from this product under normal circumstances if it is involved in a fire.

**Extinguishing Media:** Not Combustible. Use extinguishing media suited to burning materials.

**Fire Fighting:** When fighting fires involving significant quantities of this product, no special equipment is believed to be necessary.

**Flash point:** Does not burn.

**Upper Flammability Limit:** Does not burn.

### Section 6 - Accidental Release Measures

**Accidental release:** In the event of a major spill, prevent spillage from entering drains or water courses. Wear full protective clothing including eye/face protection. All skin areas should be covered. See below under Personal Protection regarding Australian Standards relating to personal protective equipment. Suitable materials for protective clothing include rubber, PVC. Eye/face protective equipment should comprise as a minimum, protective glasses and, preferably, goggles. If there is a significant chance that dusts are likely to build up in cleanup area, we recommend that you use a suitable Dust Mask. Use a P1 mask, designed for use against mechanically generated particles eg silica & asbestos. Otherwise, not normally necessary.

Stop leak if safe to do so, and contain spill. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. Consider vacuuming if appropriate. Recycle containers wherever possible after careful cleaning. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. This material may be suitable for approved landfill. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

## Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. ### Potential Health Effects

**Inhalation:**

**Short Term Exposure:** Long term inhalation of high amounts of any nuisance dust may overload lung clearance mechanism. Available data indicates that this product is irritating to nose, throat and respiratory system causing coughing and sneezing.

**Long Term Exposure:** Inhalation of respirable crystalline silica may lead to silicosis which is a lung condition.

**Skin Contact:**

**Short Term Exposure:** Irritating and drying to skin. May cause alkaline burn and irritant or allergic dermatitis.

**Long Term Exposure:** Classified as a potential sensitiser by skin contact. Prolonged and repeated skin contact with cement in wet concrete, mortars and slurries has been associated with both irritant dermatitis and allergic (contact) dermatitis. Sensitisation is due to the presence of traces of water soluble hexavalent chromium in cement.

**Eye Contact:**

**Short Term Exposure:** This product is an eye irritant. Irritating and mildly corrosive to eyes. May cause chemical conjunctivitis and redness and watering of eyes with damage to cornea.

**Long Term Exposure:** No data for health effects associated with long term eye exposure.

**Ingestion:**

**Short Term Exposure:** Significant oral exposure is considered to be unlikely. This product is likely to cause headache and gastric disturbance such as nausea and vomiting if ingested in significant quantities. May cause burning sensation and abdominal discomfort. Mildly corrosive to mouth and throat.

**Long Term Exposure:** No data for health effects associated with long term ingestion.

**Carcinogen Status:**

**SWA:** No significant ingredient is classified as carcinogenic by SWA.

**NTP:** No significant ingredient is classified as carcinogenic by NTP.

**IARC:** No significant ingredient is classified as carcinogenic by IARC. However, cements may contain 0.1%-35% crystalline silica (CAS no. 14808-60-7) with 25 - 40% of particles in the respirable range.
