### 4. FIRST AID MEASURES

(sen) - Sensitiser. A substance that can 'sensitise' the skin or respiratory system, inducing a state of hypersensitivity to it, so that on subsequent exposures, an allergic reaction can occur (which would not develop in non-sensitised individuals).
