4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

LARGE SPILLS

Prevent further leakage or spillage if safe to do so. Slippery when spilt. Avoid accidents, clean up immediately. 7. HANDLING AND STORAGE
