4. FIRST AID MEASURES

Skin Contact: If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. For gross contamination, immediately drench with water and remove clothing. Continue to flush skin and hair with plenty of water (and soap if material is insoluble). 5. FIRE FIGHTING MEASURES

Specific hazards: Extremely flammable aerosol. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. 7. HANDLING AND STORAGE
