#### 4. FIRST AID MEASURES

**Skin Contact:** If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. ### 5. FIRE FIGHTING MEASURES

**Suitable extinguishing media:** If material is involved in a fire use alcohol resistant foam or dry agent (carbon dioxide, dry chemical powder).

**Specific hazards:** Flammable liquid and vapour. May form flammable vapour mixtures with air. Flameproof equipment necessary in area where this chemical is being used. Nearby equipment must be earthed. Electrical requirements for work area should be assessed according to AS3000. Vapour may travel a considerable distance to source of ignition and flash back. ### 7. HANDLING AND STORAGE

Handling: Avoid eye contact and skin contact. Avoid inhalation of vapour, mist or aerosols.
