## 4. FIRST AID MEASURES

## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

### LARGE SPILLS

Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand or soil). Sweep or vacuum up, but avoid generating dust.
