## 6. ACCIDENTAL RELEASE MEASURES

### SMALL SPILLS

Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. ## 7. HANDLING AND STORAGE

**Handling:** Avoid skin and eye contact and the inhalation of vapour.
