# 4. FIRST AID MEASURES

#### Inhalation:

# 6. ACCIDENTAL RELEASE MEASURES

#### Emergency procedures/Environmental precautions:

SMALL SPILLS: Wipe up with absorbent (clean rag or paper towels). Allow absorbent to dry before disposing with normal household garbage.
