4. FIRST AID MEASURES

SMALL SPILLS

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.

Wash contaminated clothing and other protective equipment before storing or re-using.
