4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance.

Notes to physician: Treat symptomatically. Subcutaneous injection from high-pressure equipment can leave a small, sometimes bloodless, puncture wounds deep into the extremity. Within 24 hours, there is usually extensive swelling, discolouration and intense pain in the affected part. Requires immediate treatment, otherwise disfigurement of affected part may occur.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS
