### 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

### SMALL SPILLS

### LARGE SPILLS

## 7. HANDLING AND STORAGE
