4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

7. HANDLING AND STORAGE

Handling: Product is designed for use diluted with water. Dilutions of this product should be handled in the same manner as for the concentrate, as outlined in this safety data sheet.
