Product Description

Ecocare Brush and Roller Cleaner is an ecological non-hazardous cleaner and conditioner that allows simple clean up or reconditioning of brushes and rollers. Reducing cleaning time, it is reusable and can be used time and time again for both water-based and mineral turps-based paints.

Where to use

Suitable for use with water-based and mineral-turps based brushes and rollers.

Directions for use

- Scrape or squeeze excessive paint from brushes or rollers.
- Add the required amount of Ecocare Brush & Roller Cleaner into clean water. For water-based paints use 25ml per litre and for turps-based paints use the solution neat without water.
- Fully submerge and soak the bristles or roller sleeve in the solution. Periodically agitate the brush or roller to achieve optimum results.
- Remove the brush/roller after the minimum dwell time has elapsed. *(Roller sleeves may require overnight dwell time)*
- Place the brush into clean water and if required rinse briefly under running water
- The solution can be reused by simply straining through a filter into a clean container or disposed as waste liquid (grey water) onto lawns or garden beds. The solids captured in the filter can be left to drain and then discarded through general waste.

Mixing Ratio

General cleaning water-based paints	25ml solution per litre of clean water	Brushes Rollers	15-30 minutes
General cleaning solvent-based paints	Use neat without dilution	Brushes Rollers	Up to 12 hours
Removing stubborn residue	Use neat without dilution	Brushes	Up to 24 hours

Periodically agitating during the dwell time will improve cleaning effectiveness.

Storage

Protect from extremes of temperature. Store between 5°C and 30°C.

Keep out of reach of children. May cause irritation, avoid contact with eyes and prolonged contact with skin.
