Directions for use

- To achieve the certified slip rating Haymes Non-Slip Additive must be added to the topcoat at a ratio of 20 grams per litre. Two coats must be applied at the specified coverage rate for the topcoat.
- Sprinkle the additive into the paint in small amounts while stirring with a broad flat stirrer
