3. HAZARDS IDENTIFICATION

Poisons Schedule: None allocated.

4. FIRST AID MEASURES

Inhalation: Remove victim from area of exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

5. FIRE FIGHTING MEASURES

11. TOXICOLOGICAL INFORMATION

However, due to the particle size of the silica (sand) this is not expected to be relevant providing this product is used as recommended and good occupational work practices are observed.
