Haymes Artisan Collection Oxidising Patina is a specially formulated oxidant for use with the Artisan Collection Real Iron or Real Copper paints. The oxidant reacts with these paints to create a rusted iron finish or Copper Verdigris finish. Oxidising Patina is suitable for Interior & Exterior use. To seal and isolate the effect created by the oxidising patina, apply one coat of Artisan Collection Natural Clear Matte.

Application

Do NOT apply if the ambient temperature is less than 10°C or greater than 35°C, or if conditions will drop below 10°C during the drying period. Under warmer conditions refer to Thinning advice. All times quoted assume ambient conditions of 25°C and 50% relative humidity. At cooler temperature or higher humidity drying times will be extended.

To avoid skin contact, we recommend the use of disposable or rubber gloves.

- 1. Use only on surfaces pre-painted with Haymes Real Iron or Real Copper Paint. Drying time of the Real Iron or Real Copper paint will affect the finished appearance. Prior to commencing application to your project, practice your application technique on an off-cut or large piece of board.
- 2. Rust Load a broad bristle brush with oxidant and apply over Real Iron Paint with sweeping crisscross strokes.
- 3. Verdigris Oxidising Patina may be applied over Real Copper Paint using a variety of techniques such as spray, brush, fabric or sponge.
- 4. Oxidising continues after the Oxidising Patina has dried. If a more obvious effect is required apply a second or third coat.

IMPORTANT NOTE:

The finished result of decorative finishes will vary dependent upon the applicator and the application technique used. Haymes Paint recommend a sample application be conducted prior to undertaking your project to ensure consistency of outcome. This is due to the variance that may be experienced between the Haymes finished sample and that achieved by the applicator. Thinning

For a Rust effect over Real Iron Paint, thinning is not recommended. For a Verdigris effect over Real Copper Paint, a more subtle finish may be achieved if desired by thinning with up to 90% water.

Care and maintenance

Apply one coat of Artisan Collection Natural Clear Matte to achieve a more durable finish.

Storage

Protect from extremes of temperature. Store between 5°C and 30°C.

Reacts with iron, steel, aluminium and copper. Store only in the original container. Store away from incompatible materials such as reducing agents and solvents.

Safety and First Aid

Keep out of reach of children. Read label before use. Wash exposed skin thoroughly after handling. Wear eye protection/face protection. IF IN EYES, rinse cautiously with water for several minutes. Remove contact lenses if present and easy to do. Continue rinsing. If eye irritation persists get medical advice/attention.
