4. FIRST AID MEASURES

Inhalation: Short term exposure. Corrosion of mucous membranes, irritation, nausea, vomiting, difficultybreathing, headache, drowsiness, symptoms of drunkenness, lung congestion. Long term Exposure. Possible lungand respiratory tract damage including pulmonary oedema, may trigger pre-existing respiratory complaints.

Skin Contact: Short term exposure. Severe burns, redness and irritation. Long term exposure. Permanentscaring. Prolonged exposure to a diluted form may cause irritation, redness and dermatitis.

Eye contact: Short term exposure. Severe irritation, serious eye damage. Long-term exposure. Permanentdamage to eyes including blindness.

7. HANDLING AND STORAGE

Handling: Avoid eye contact and skin contact. Avoid inhalation of dust.

Storage: Store in a cool, dry, well-ventilated place and out of direct sunlight. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Store locked up. Store in corrosive resistant container with a resistant inner liner. Keep container standing upright. Keep containers closed when not in use - check regularly for spills.

10. STABILITY AND REACTIVITY

Chemical stability: Stable at normal temperatures and pressure

Conditions to avoid: Avoid contact with incompatible materials.

Incompatible materials: Strong Oxidising Agents, Strong Alkalies, Mild steel, & Light Metals (Al, Sn, Pb, Zn)Explosive reactions may occur with strong oxidising agents. Violent heat producing reactions may occur with strong alkalies. An explosive, flammable gas (Hydrogen gas) is produced when in contact with metals.
