**Description:** EPiC AquaEpoxy is a high strength, water based, low VOC, 2 pack epoxy concrete floor coating which offers excellent protection against petrol, oil, fatty oils, alkali, acid and efflorescence. It is food grade compliant and can be used in a variety of INTERNAL commercial applications including restaurants, hospitals and supermarkets.
