#### 4. FIRST AID MEASURES

Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). ### 7. HANDLING AND STORAGE

**Handling:** Avoid eye contact and repeated or prolonged skin contact. Avoid inhalation of vapour, mist or aerosols.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15 minute period which should not be exceeded at any time during a normal eight-hour workday.
