4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove victim from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow patient to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre or a Doctor; or for 15 minutes and transport to Doctor or Hospital.

7. HANDLING AND STORAGE

10. STABILITY AND REACTIVITY

Chemical stability: Store away from alkaline corrosive materials and oxidising agents

Conditions to avoid: Elevated temperatures and sources of ignition.

Incompatible materials: Oxidising agents.

Hazardous decomposition products: Solutions will corrode mild steel, lead, zinc & aluminium & will attack brass, copper & phosphor bronze. The material is stable but solutions slowly hydrolyse to form ammonium bisulphate particularly at elevated temperatures. Can react violently or explosively with metal nitrates or nitrites if heated, fuming nitric acid & chlorine gas
