#### 4. FIRST AID MEASURES

## **10. STABILITY AND REACTIVITY**

Chemical stability: This material is thermally stable when stored and used as directed.

Conditions to avoid: Store away from alkaline corrosive materials and oxidising agents

Incompatible materials: Oxidising agents.

Hazardous decomposition products: Oxides of carbon and nitrogen, smoke and other toxic fumes.

**Hazardous reactions:** Solutions will corrode mild steel, lead, zinc & aluminium & will attack brass, copper & phosphor bronze. The material is stable but solutions slowly hydrolyse to form ammonium bisulphate particularly at elevated temperatures. Can react violently or explosively with metal nitrates or nitrites if heated, fuming nitric acid & chlorine gas
