#### Application

TUTTI FRUITTI Disinfectant is recommended for all washable hard surfaces such as floors and walls in washrooms.

#### Directions

- 1. For general cleaning dilute **TUTTI FRUITTI** Disinfectant 1:60 with water.
- For cleaning and disinfecting dilute **TUTTI FRUITTI** Disinfectant 1:20 with water.
- 2. For spray and wipe cleaning, fill trigger spray with diluted solution.

Apply to surface using clean cloth. For bucket cleaning, fill bucket with diluted solution.

- Apply to surface, use cloth for small areas, mop for floors.
- 3. Rinse cloth or mop when soiled.
- 4. Allow surfaces to air dry. DO NOT MIX WITH DETERGENT OR OTHER CHEMICALS
